**ADVERTISEMENT**

Online applications are invited from Arunachal Pradesh Schedule Tribe (all the three posts are reserved for APST candidate) for filling up 3 (three) posts of Assistant Jailor (Female-2 and Male-1), Group- B (Non Gazetted), under the Directorate of Prisons and Correctional Administrative, Department of Home, Govt. of Arunachal Pradesh in the pay band of Rs. 9300-34800/- Grade pay of Rs. 4200/- PM (pre-revised 6<sup>th</sup> pay) and plus other allowances as admissible to Arunachal Pradesh Govt. employees from time to time. The vacancy position is subject to variation.

**(1) EDUCATIONAL QUALIFICATION :**

Candidate applying for the post must be a graduate in Arts/Science/ Commerce from a recognized University.

**(2) AGE LIMIT:**

The candidates must have attained 20 years of age and should not be more than 25 years as on **09.12.2018**. However, the upper age limit is relaxable to 5 years for APST candidates and another 5 years relaxation to APST candidates for A P state govt. employees.

**(4) PHYSICAL EFFICIENCY TEST:**

The candidate will be put through physical efficiency test before written examination as indicated below:

For Male Candidates.

1. 100 meter race in 16 seconds.
2. 1500 meters in 6 minutes.
3. High Jump-130 cms.
4. Long Jump-3.20 meters
5. Bend/stretch- 6 times.

For Female Candidates.

1. 100 meters race in 18 seconds.
2. 800 meters in 4 minutes.
3. High Jump- 110 cms.
4. Long Jump-3.20 meters.
5. Bend/Stretch-6 times.

(5) **METHOD OF SELECTION :-**

The candidate who qualified in Physical Efficiency Test will have to appear in written examination in the following subject followed by Viva-Voce/Interview to be conducted by the Commission at Itanagar on the basis of which selection will be made.

1. General English and Essay	-100 marks
2. General Knowledge	-100 marks
3. Viva-Voce test	-25 marks
Total Marks -225 marks	

A candidate who has secured a minimum of 33 % or more marks in each written examination papers and has secured 45% of marks out of aggregate total marks in the written examination papers shall be eligible for Interview/Viva-Voce test, In other words selection for viva-voce test shall be based on the aggregate total marks secured in the written examination papers and subject to ratio of 1:3. The candidates securing less than 33% of marks in any of the written examination paper shall not be eligible for appearing in the viva-voce test.

**N.B** The Commission will conduct recruitment test (Objective Type) before written examination, if it is deemed necessary to do so.

(6) **HOW TO APPLY :-**

Candidates are required to apply online only through the official website [www.appsconline.in](http://www.appsconline.in). Brief instructions for filling up online application are available on the above mentioned website.

(7) **Scanned copies of following documents and information are to be attached/uploaded.**

- (i) Scanned signature of the candidate on white paper with black ink pen(20-60 kb in jpg format).
- (ii) Latest/Recent passport size photo(40-100 kb in jpg format).

(8) **The candidates who have been declared qualified in written examination will have to submit Xerox copies of the following documents/information to the Commission before the interview date.**


- (i) Recent passport size photograph
- (ii) Matriculation certificate issued by Board/University for proof of date of birth.
- (iii) Class XII Certificate with Marksheet.
- (iv) Degree certificate with Mark sheet issued by the Assistant Registrar/Registrar/Controller of Examination/Vice Chancellor of the concerned University to ascertain educational qualification.
- (v) Post Graduate certificate (if any).
- (vi) APST Certificate.
- (vii) Any other documents as may be relevant.
- (viii) Intimation letter to HoD for those who are in regular Govt. Service.

**Qualified candidates will have to produce the above mentioned Certificates/Documents and marksheets in original at the time of interview. Failing which he/she will not be allowed to appear in the interview.**

(9) The decision of the Commission as to the eligibility or otherwise of candidate for admission to written examination or selection will be final and no correspondence or personal enquiry will be entertained.


