ADVERTISEMENT

Applications in prescribed form are invited from the APST candidates only for filling up 2 (two) posts of Teacher-cum-Librarian, under the department of Prisons and correctional administrative (Home deptt.), Govt. of Arunachal Pradesh in the pay scale of level-6 of pay matrix as per 7th pay, Group-B (Non-Gazetted, Non-Ministerial) and other allowances as admissible to Arunachal Pradesh Govt. employees from time to time. The vacancy position is subject to variation.

[A] EDUCATION QUALIFICATION:-

Candidate applying for the post must be a graduate from a recognized University and possessing a diploma in Library Science.

[B] AGE LIMIT:- The candidates must have attained 18 years of age and should not be more than 32 years as on 20th February/2020. However, the upper age limit is relaxable in accordance with the instructions issued by the Govt. of Arunachal Pradesh from time to time.

[C] METHOD OF SELECTION :-

The eligible candidate will have to appear in written examination in the following subject :-

1. General English	Maximum Marks=100
2. General Knowledge	Maximum Marks=100
3. Library & Information science	Maximum Marks=100
4. Interview/Viva-Voce	<u>Maximum Marks= 40</u>
	Total Marks = 340

A candidate who has secured a minimum of 33 % or more marks in each written examination papers and has secured 45% of marks out of aggregate total marks in the written examination papers shall be eligible for Interview/Viva-Voce test. In other words selection for viva-voce test shall be based on the aggregate total marks secured in the written examination papers and subject to ratio of 1:3. The candidates securing less than 33% of marks in any of the written examination paper shall not be eligible for appearing in the viva-voce test.

N:B The Commission will conduct recruitment test (Objective type) before written examination, if it is deemed necessary to do so.

[D] HOW TO APPLY :-

Candidates are required to apply online through the official website www.appsconline.in
Brief instruction for filling up online application are available on the above mentioned website.

[E] Scanned copies of following documents and information are to be attached/uploaded.

a) Scanned signature of the candidate on white paper with black ink pen (20-60 kb in JPG format).

b) Latest/Recent passport size photo (40-100 kb in JPG format).

[F] The candidates who have been declared qualified in written examination will have to submit Xerox copies of the following documents/information to the Commission before one week from the actual date of interview.

a) Recent passport size photograph.

b) Matriculation certificate issued by Board/University for proof of date of birth.

c) Class-XII certificate with marksheet.

d) Degree certificate with marksheet issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain educational qualification.

e) Diploma certificate with marksheet of Library Science from recognized University.

f) APST certificate for APST candidates.

g) Intimation letter to HoD/NoC for those who are in regular Govt. service.

[G] Qualified candidates will have to produce the above mentioned certificates/documents and marksheet in original at the time of interview, failing which he/she will not be allowed to appear in the interview.

[H] The decision of the Commission as to the eligibility or otherwise of candidate for admission to written examination or selection will be final and no correspondence or personal enquiry will be entertained.

[I] Closing date 20th February/2020 (till 1600 hours).

[J] Examinaton fees :- Candidates are required to pay fee of Rs. 200/- (Rupees two hundred) only through online mode only.
